

LEHMAN'S OFFICIAL SWEEPSTAKES RULES
GET GROWING SWEEPSTAKES

1. **ELIGIBILITY.** No purchase necessary. This Sweepstakes (the "Sweepstakes") brought to you by LEHMAN HARDWARE AND APPLIANCES, INC., also known as LEHMAN'S, an Ohio corporation ("Sponsor") is governed by these rules (the "Official Rules"). The Sweepstakes is open to U.S. residents (excluding Puerto Rico) age 18 or older at the time of entry (the "Entrant"). Employees, directors, officers and principals, of the Sponsor, its subsidiaries, affiliates, contractors, agents and members of their immediate families or households are not eligible to participate. Upon entering this Sweepstakes entrants agree to waive any rights their state of residence may provide in regard to sweepstakes and contests. This Sweepstakes is void where prohibited by law.

3. **PRIVACY POLICY.** The information submitted with your Sweepstakes entry will only be used by Sponsor, in accordance with applicable data protection regulations and the Privacy Policy of the Company's web site [<https://www.lehmans.com/privacy>], for the purposes of administrating your participation in the Sweepstakes. The information collected will be maintained for one (1) year following the end of the Promotion Period and will then be properly deleted. Sponsor will not transfer or disclose the information submitted by you to any third parties.
